

MINUTES
LAFAYETTE COUNTY SCHOOL BOARD
PUBLIC BUDGET HEARING, SEPTEMBER 8, 2022

The Lafayette County School Board convened on Thursday, September 8, 2022 at 6:00 p.m. for a Public Hearing on the Final Millage and Budget for 2022-2023 school year. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; Mrs. Marion McCray, Vice Chair; and Mrs. Leenette McMillan-Fredriksson, School Board Attorney. Mr. Taylor McGrew, Member was absent. Administrators present were Mrs. Tammi Maund, Director of Finance and Mrs. Alissa Hingson, Director of Teaching and Learning Services.

CALL TO ORDER

Chairperson Amanda Hickman called the Public Hearing to order at 6:05 p.m.

MILLAGE RATES APPROVED FOR 2022-2023

Mrs. Tammi Maund reviewed the millage rates and budget, including capital outlay expenditures.

The public was given the opportunity for questions and/or input at this time. Following this review, the 2022-2023 millage rates were approved as listed below:

- ✓ The tentative Required Local Effort rate of 3.1820 mills was unanimously approved on a motion by Mrs. Marion McCray and a second by Mr. Jeff Walker.
- ✓ On a motion by Mr. Darren Driver and a second by Mr. Jeff Walker, the tentative Discretionary rate of .7480 mills was unanimously approved.
- ✓ The tentative Capital Outlay rate of 1.5000 mills was unanimously approved following a motion by Mr. Jeff Walker and a second by Mr. Darren Driver.

SCHOOL BOARD APPROVES RESOLUTION NO. 23-03

Mrs. Marion McCray moved to approve Resolution Number 23-03 (ESE524) regarding adoption of Resolution determining Revenues and Millages Levied. Mr. Jeff Walker seconded the motion, which was unanimously approved. (Resolution on file in district office)

Mrs. Marion McCray moved to approve Resolution Number 23-04 regarding adoption of the final budget for 2022-2023. Mr. Jeff Walker gave the second. Motion carried unanimously. (Resolution on file in district office)

SCHOOL BOARD APPROVES FINAL BUDGET

Mr. Jeff Walker moved to approve the District Summary Budget FY 2022-2023. Mr. Darren Driver gave the second. Motion to approve the 2022-2023 final budget was unanimously approved.
