LAFAYETTE COUNTY SCHOOL BOARD

REGULAR MEETING, JULY 20, 2021

The Lafayette County School Board convened in regular session, Tuesday, July 20, 2021 beginning at 6:00 p.m. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Ms. Marion McCray, Vice Chair; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; Mr. Taylor McGrew, Member and Deputy Jacquelyn Clark. Ms. Leenette McMillan-Fredriksson, School Board Attorney was not present.
