**Parental Involvement Mission Statement**

The Lafayette County School District believes parents are a child's first and most important, teacher. The District Parent and Family Engagement Program will outline ways Lafayette District will foster parent and family engagement in the education of their children. This can be accomplished by keeping them informed, equipping them with the tools and knowledge to assist their children and by offering opportunities for teachers and parent to discuss ways to help each child achieve their maximum potential.

**Engagement of Parents and Families**

Lafayette County Schools will involve parents/families in an organized, ongoing, and timely manner, in the planning, review, and improvement of Title I programs including involvement in the decisions regarding how funds for Parent and Family Engagement will be used [Sections 1118(c)(3), 1114(b)(2), and 1118(a)(2)(B)]. All parents/families have the opportunity to become involved at Lafayette County Schools throughout the school year. Lafayette County Schools offer the following activities to all parents/families: Meet Your Teacher Day/Open House, Title I Annual Meeting, Parent-Teacher Conferences, Informal Volunteer Orientation, School Advisory Council (SAC) Meetings, club/student organization meetings, and extra-curricular activities.

Information concerning time, dates and activities will be available in newsletters, take home flyers, the school's website, social media, and phone calls. Parents/families will be encouraged to join and participate in any of the above groups and have the opportunity to participate in the decision making process for Lafayette County Schools.

SAC is the decision-making entity of the schools. Parents/families are asked to participate in a survey seeking input on activities, training and materials they need to help their child. The SAC Committee will help develop, review and discuss strategies and activities for the School Improvement Plan and for the Parent Family Engagement Plan.

Use of Parent and Family Engagement Funds will be discussed at SAC meetings and at the Annual Title 1 Meeting held no later than the first 6 weeks of school. Documentation of parent/family participation will include agendas, minutes of SAC meetings, sign-in sheets, and surveys.

**Technical Assistance**

The Parent and Family Engagement Coordinator at each school will assist Lafayette County Schools in developing and presenting Parent and Family Engagement programs throughout the year to improve academic success of all students and overall school performance.

Parent/family input is requested at the School Advisory Council Meetings as well as Migrant, ELL and Homeless Parent/family Meetings. Parents/families provide input into the types of meetings/workshops that are beneficial to them in assisting their children and ensuring the academic success of all children. The LEA reviews all recommendations from the parents/families and ensures that all District Parent and Family Engagement Initiatives are included in the plan.

## Coordination and Integration

1	Head Start	Parents of Head Start students will be informed of Title I parent and family engagement activities and invited to attend. Title I will also arrange for transitioning Head Start students and parents to attend a tour of Kindergarten classes in April and to talk with Kindergarten teachers. Also, the Parent and Family Engagement Coordinator will provide parents with information (brochures, etc) on preparing their child for Kindergarten.

3	Title I, Part C	The Director of Teaching and Learning Services is responsible for all federal programs and therefore can ensure coordination in planning between Title I, Part A and Title I, Part C parent and family engagement activities. Services are provided to migrant families in both Title I schools in the district. Flyers and invitations to these meetings, as well as any handouts, will be provided in Spanish, the primary home language other than English.
4	Title II, Part A	Title II funds will be used in coordination with the Title I, Part A, Parent and Family Engagement funds, to provide in-service to teachers on parent and family engagement topics specified.
5	Title III	When funds are received for this project, they are used to improve the educational achievement of ELLs by increasing their English language proficiency and ability to meet the same challenging State academic content and student academic standards as all children are expected to meet.
6	Title IV	Title IV funds will be used to focus on providing well rounded educational opportunities, activities to support Safe and Healthy Students, and/or activities to support Effective Use of Technology.
7	Title V	Title V partially funds the Director of Teaching and Learning to assist teachers analyzing student data implementing Florida State Standards and with low achieving subgroups to achieve Florida Standards.
8	Title IX	All parents of Homeless students will be included in all Title I parent and family engagement activities.
9	LES Kindergarten - 5th grade and LHS 6 <sup>th</sup> -12 <sup>th</sup> grades	Lafayette County School students and parents will be invited to a meeting in coordination with the Parent and Family Engagement team and other Title I program providers, to meet the Superintendent, Principal and grade level teachers. A basic outline of each grade level will be given by teachers and "meet and greet" will follow the meeting.

## Annual Evaluation

In the Spring of the school year, the LEA Title I Personnel will conduct a survey of parents/families regarding the activities in the current PFEP. This survey will be conducted using Survey Monkey survey system and/or the Cognia survey system for school accreditation, both are online survey systems and provide data analysis. Parents/families not having access to the Internet may complete a paper copy of the survey and LEA staff will input those results into the online system. The survey will list specific components of the plan and ask for parent opinion on an activity's effectiveness in improving the quality of the school. Parents/families will also be asked to list any barriers to their participation in the activities. The survey is also made available at parent and family meetings of programs, such as Migrant, Homeless, ELL and ESE. In addition, a roster of attendance for each activity will be maintained and data will be compiled on participation rates. Parents/families will be asked to complete an evaluation of the activity's usefulness. Translation, both oral and written, will be provided in Spanish, the primary home language other than English, by the full-time language facilitators located at the elementary and high school. The Title I Director will collect data from the survey, and the various activities within the current PFEP, and then will present this information to the principals at the Title I schools. Principals will present the information at the schools advisory council meeting. This information will be used to design new activities, which will better meet the needs of parents/families and will be used in planning Parent and Family Engagement activities for the following year.

## Annual Parent and Family Engagement Meeting

Lafayette County Schools will conduct annual meetings designed to inform parents/families of participating children about the nature of the school-wide Title I program, learning gains, school choice, and the rights of parents. [Section 1118(c)(1)].

## Flexible Parent Meetings

Using this feedback, topics and scheduling of future meetings/workshops will be adjusted if needed in order to address parental concerns. Teachers will hold parent conferences before school or evening when needed.

### Communication and Accessibility

Lafayette County Schools inform parents/families about academic assessments used to measure student progress and the proficiency levels students are expected to meet via newsletters, letters from the principal and parent conferences. At the beginning of the year, parents/families are invited to Open House. Teachers meet with parents and students to provide information specific to their grade level and/or subject area. In addition, parents are provided with information regarding the Parent and Family Engagement Plan, postsecondary and career/technical opportunities, graduation requirements, middle school promotion, school clubs/organizations, community and family support organizations, Skyward training and information, and clearinghouse eligibility for student athletes. Information will be provided for parents/families about Title I at the Annual Title I Parent and Family Engagement meeting. All of this information is also available on our school website. Information about Title I is also distributed through the district composed letters sent home with students at the beginning of the school year.

A Student-Teacher-Parent Compact is discussed and signed at the beginning of school. The Compact includes the school's expectations for students, teachers, and parents. The compact is reviewed and used during the course of the year as needed. Various information is provided in school newsletters, teacher notes, district curriculum grade level expectations, parent flyers, and student data reports are sent home regularly to inform parents/families of student progress.

Student progress is monitored through district-wide progress monitoring tools, such as I-Ready and District Curriculum Assessments. Students will also be monitored through the State Progress Monitoring System to measure student progress. Parents will be informed of student progress, according to the assessments, at parent conferences. Grades are available to parents through Skyward, but progress reports are mailed home the middle of each reporting period to parents of students with a D or F in any class to inform them of their student's danger of failing. School and district websites offer information to parents/families concerning state assessments and parent trainings.
