### 8th Grade Class Trip

Mr. Edwards opened up the discussion about the 8<sup>th</sup> grade class trip covering the following topics:

Will there be an 8<sup>th</sup> grade trip to Washington D. C. in March 2021?

What are the deadlines for making decisions, bid process, reservations, collecting funds?

The minimum cost is around \$1000/person with 4 in a room. Are there less expensive options?

Are there enough fundraisers leading up to the trip to fully fund the cost of a student ticket?

Would a student need to participate in all fundraisers to pay for the trip in full?

Number of students vs. parents and siblings that attend?

Chaperone requirements and age limits?

Things that may prevent a student from attending such as discipline issues?

Deposits and refunds (Internal Accounts Procedures Handbook 8th grade section)?

If a parent purchased a ticket and has to back out can someone else purchase the ticket?

After open discussion by previous and current 8th Grade Class Sponsors, School Board Members,

and the Superintendent, some things that may be considered going forward with the 8th grade

class trip are: finding ways to reduce some of the larger expenses with the 8th grade trip such as

hotel, transportation, and food; possibly shortening the trip; refundable deposit if trip is

cancelled; and flexibility with when the trip is scheduled to be taken. All were in agreement that

another workshop needs to be held on the 8th grade class trip for future 8th grade trips.

✓ The tentative Capital Outlay rate of 1.5000 mills was unanimously approved following a motion by Mr. Taylor McGrew and a second by Mr. Jeff Walker.

This past year we received a grant to put in transfer switches for generators when we need to open a shelter for a hurricane. We are needing to fix the air conditioning in the Gym in the event we need to open a shelter and are current running at half capacity with the air conditioners now. This project was added to the Project Priority List which we just received approval for. This was not a sealed bid process. The district is wanting to go with the proposal we received from Engineered Cooling. Mr. Pearson explained that we are wanting to get the air conditioning fixed as soon as possible as hurricane season is upon us. Following discussion,

the emergency AC unit purchase was unanimously approved on a motion by Mr. Jeff Walker and a second by Mr. Taylor McGrew.
