# MINUTES LAFAYETTE COUNTY SCHOOL BOARD WORKSHOP, AUGUST 18, 2015

The Lafayette County School Board held a workshop on Tuesday, August 18, 2015 beginning at 5:00 p.m. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Mr. Jeff Walker, Vice-Chair; Mr. Darren Driver, Member; Mrs. Marion McCray, Member; Mr. Taylor McGrew, Member; and Ms. Leenette McMillan-Fredriksson, School Board Attorney.

# <u>Technology Update - Presentation by Lisa Hancock, Instructional Technology Coach</u>

Lisa Hancock updated the School Board on technology implementations at LES and LHS during the 2014-2015 school year. She also shared software and online applications that are being introduced this year. Mrs. Hancock gave a brief explanation of the many software and online applications utilized by teachers and students. She noted that the school district pays for several of these applications, but many are free. Board members had the opportunity to use chromebooks and participate in an online game that can be used by teachers in preparing students for tests. The Superintendent and School Board thanked Mrs. Hancock for a very interesting and informative presentation.

### **Other Concerns**

**Food Service Program** — Superintendent Edwards talked with the School Board about the possibility of outsourcing our food services. He explained that he has been talking with a representative from Sodexo, a leading outsourcing services company. Sodexo is a leading provider of service solutions serving customers in corporations, health care, public schools, and college campuses.

In regard to food services, Sodexo employs highly qualified people who know the food service business. They are able to offer more food choices and often incorporate produce from local

farmers. When Sodexo comes in a school district, they run all aspects of the food service program

from management and training of food service personnel to preparation of menus that meet the

requirements of DOE and the Dept. of Agriculture.

Mr. Edwards shared that Jackson County School District has outsourced its food services to

Sodexo. On a visit to Jackson County, Superintendent Edwards and Joey Pearson, Food Service

Director, had the opportunity to talk with food service staff that all seemed to be very pleased with

Sodexo.

Mr. Edwards informed the Board that a Sodexo representative will be in Madison County School

District on September 8<sup>th</sup> and would like to visit our school district as well. Board members

welcomed the visit, stating that they would like to learn more about outsourcing food services. The

possibility of outsourcing custodial services may also be looked at. Mrs. Hickman asked if it could be

arranged for the Sodexo representative to meet with the Board at their September 8<sup>th</sup> workshop.

Superintendent Edwards stated that he would contact the representative about coming to the

workshop. It was noted that should the school district decide to go this route, Requests for Proposals

would be sent to several outsourcing companies.

### **CALL TO ORDER**
