MINUTES LAFAYETTE COUNTY SCHOOL BOARD REGULAR MEETING, FEBRUARY 19, 2019

- 4.02 FLORIDA DEPT. OF CORRECTIONS' INTERAGENCY/PUBLIC WORKS AGREEMENT The Local Agreement between the State of Florida, Dept. of Corrections, through its institution/facility, Mayo Correctional, and the Lafayette County School Board was presented for the School Board's approval. This three year agreement is in accordance with Florida Statutes, Inmate Work Program and Use of Inmates in Public Works, Florida Administrative Code. Following discussion, Mrs. Marion McCray moved to approve the Interagency/Public
