MINUTES LAFAYETTE COUNTY SCHOOL BOARD WORKSHOP, JULY 16, 2019

The Lafayette County School Board met in workshop session on Tuesday, July 16, 2019 beginning at 5:00 p.m. In attendance were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Mrs. Marion McCray, Vice-Chair; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; Mr. Taylor McGrew, Member; and Ms. Leenette McMillan-Fredriksson, School Board Attorney. Administrators present were Mrs. Tammi Maund, Director of Finance; Mr. Stewart Hancock, LHS Principal; Mr. Stephen Clark, LES Principal; Mrs. Alissa Hingson, Director Teaching and Learning Services; Mr. Joey Pearson, Director of Support Services; and Mr. Gerald Powers, Director of Safety and Mental Health. The following items were discussed:

Valedictorian/Salutatorian/Honor Student

Stewart Hancock and Melissa Hewett, LHS Guidance Counselor, talked with the School Board regarding the requirements for Valedictorian and Salutatorian. Mrs. Hewett began by giving each board member a handout outlining the requirements a student must meet in order to be named Valedictorian/Salutatorian. Eligibility is based on the successful completion of the Scholar Diploma Designation Requirements. She explained that all course work taken in each academic area of study (English, Math, Science, Social Studies and Foreign Language) is averaged into the final numerical grade point average calculation to determine Valedictorian and Salutatorian. Valedictorian will be the Scholar Diploma Designation recipient with the highest numerical grade point average. Salutatorian will be the Scholar Diploma Designation recipient with the second highest numerical grade point average.

Mrs. Hewett informed the School Board that beginning with the 2019-2020 school year, North Florida Community College will no longer provide numerical grades for our students taking dual enrollment

courses. NFCC will only send a letter grade to the high school for each dual-enrolled course. Therefore,

a grading scale transfer has been developed. Mrs. Hewett presented a proposed NFC to Lafayette High

School Dual-Enrollment Grade Conversion for the School Board's consideration. The grade conversion

chart was discussed at length with board members asking numerous questions and offering input in an

effort to make it fair and equitable for students taking dual enrollment courses as well as for those taking

high school courses. With time running out, it was decided to discuss this matter further at the regular

meeting following the workshop.

Superintendent Edwards reviewed the selection process for Honor Student stating that he/she must

be in the top 25% of the senior class within the scholar diploma designation track. The top three

candidates are determined by vote of students in grades 9-12. The top 3 candidates are then voted on

by the 6-12 instructional staff at LHS. The student receiving the most votes is named Honor Student.

Mr. Edwards noted that this award is unique to Lafayette High School, is not based solely on academics,

and has been a tradition since at least the 1950's.

Dual Enrollment

Mrs. Hewett stated that the number of students participating in the dual enrollment program at

NFCC and Big Bend Technical College has greatly increased over the past few years. Mrs. Hewett talked

about the benefits a student can receive by taking dual enrollment classes as well as some of the

4.03 SCHOOL BOARD APPROVES VOLO MASTER SERVICES AGREEMENT AND VOLO SERVICE

ORDER — Gerald Powers, Director of Safety and Mental Health, presented the VOLO Master
Services Agreement. Mr. Powers stated that this agreement will provide for an emergency
notification system for all school board personnel and will allow for immediate mass notification in
the event of an emergency. Following discussion, Mr. Darren Driver moved to approve the VOLO
Master Services Agreement and VOLO Service Order. Mrs. Marion McCray seconded the motion
which was unanimously approved. (Agreement on file in district office)

4.04 SCHOOL BOARD APPROVES AMENDMENT TO AGREEMENT WITH TSA CONSULTING

GROUP INC. – An amendment to the Retirement Plan Compliance and Administration Services

Agreement between the School Board and TSA Consulting Group, Inc. was presented for approval.

Tammi Maund, Director of Finance, explained that the amendment will eliminate all fees paid by the Lafayette District Schools for Plan administration and Compliance Services. Following discussion, Mr. Taylor McGrew moved to approve the Amendment to the Agreement between TSA Consulting Group, Inc. and Lafayette County School Board. Mrs. Marion McCray gave the second. The vote for approval was unanimous. (Agreement on file in district office)

- Agreement between Dixie County School Board (employing district) and Lafayette County School Board (cooperating district) to operate a program for School Psychology Services for the 2019-2020 school year was presented for review and approval. DCSB will supply a qualified teacher certified in School Psychology to provide school psychological services for identified students in Lafayette County Schools one day per week. DCSB will invoice our district on a quarterly basis for school psychologist services and travel costs. Following discussion, Mrs. Marion McCray moved to approve the Agreement with Dixie County to provide School Psychology Services. Mr. Darren Driver gave the second. The vote for approval was unanimous. (Agreement on file in district office)
- 4.06 SCHOOL BOARD APPROVES MENTAL HEALTH ASSISTANCE ALLOCATION PLAN The 2019-2020 Mental Health Assistance Allocation Plan was unanimously approved on a motion by Mr. Taylor McGrew and a second by Mr. Jeff Walker. The mental health assistance allocation will provide funding to assist school districts in establishing or expanding school-based mental health care. (Mental Health Assistance Allocation Plan on file in district office)
- 4.07 SCHOOL BOARD TO SEEK PROPOSALS FOR GROUP HEALTH INSURANCE In an effort to provide the best insurance package at the best rate for our employees, Superintendent Edwards recommended that the School Board request bids for employee health insurance. Following

discussion, Mr. Jeff Walker moved to seek Proposals for Group Health Insurance. The motion was seconded by Mrs. Marion McCray and unanimously approved. Oral presentations will be made on the submitted proposals at the next regular school board meeting, Tuesday, August 20, 2019.

- 4.08 **SCHOOL BOARD APPROVES TENTATIVE BUDGET FOR ADVERTISING** The 2019-2020 Tentative Budget and Millage Rate was unanimously approved for advertising following a motion by Mr. Jeff Walker and a second by Mr. Darren Driver. The first public budget hearing is scheduled for Tuesday, July 30, 2019 beginning at 6:00 p.m. (Budget information on file in district office)
