# MINUTES LAFAYETTE COUNTY SCHOOL BOARD SPECIAL SESSION, JUNE 29, 2017

The Lafayette County School Board convened in special session on Thursday, June 29, 2017 at 12:00 noon. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Marion McCray, Vice Chair; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; and Mr. Taylor McGrew, Member. Mr. Darren Driver, Member, joined the meeting via telephone. Mrs. Amanda Hickman, Chairperson; Mr. Taylor McGrew, Member; and Ms. Leenette McMillan-Fredriksson, School Board Attorney, were absent. Administrators present were Mr. Stephen Clark, LES Principal; and Mrs. Tammi Maund, Director of Finance.

## CALL TO ORDER

Mrs. Marion McCray called the special school board meeting to order. Mr. Edwards gave the invocation and led the Pledge to the Flag.

### 1. ADOPTION OF AGENDA

Mrs. Marion McCray noted that there was an addition to *Action Item 3.01 (1) Resignations* – *Approve letter of resignation submitted by Susan Morgan*. Mrs. McCray asked for a motion to adopt the agenda with the change as noted. On a motion by Mr. Jeff Walker and a second by Mr. Darren Driver, the agenda was unanimously adopted by the School Board.
