MINUTES LAFAYETTE COUNTY SCHOOL BOARD SPECIAL SESSION, JUNE 30, 2016

The Lafayette County School Board convened in special session on Thursday, June 30, 2016 at 12:00 noon. Present were Mr. Robert Edwards, Superintendent of Schools; Mrs. Amanda Hickman, Chairperson; Mr. Darren Driver, Member; Mr. Jeff Walker, Member; and Mr. Taylor McGrew, Member. Mrs. Marion McCray, Member; and Ms. Leenette McMillan-Fredriksson, School Board Attorney, were absent.

CALL TO ORDER

Mrs. Amanda Hickman called the special school board meeting to order. Mr. Darren Driver gave the invocation and Superintendent Robert Edwards led the Pledge to the Flag.

CITIZEN INPUT

There was no citizen input.

SUNSHINE STATE SCHOLAR - LHS Principal, Stewart Hancock, introduced Shane Harris who was recognized for being selected as the Sunshine State Scholar for Lafayette School District.
