MILLAGE RATES APPROVED FOR 2019-2020

- (1) Required Local Effort of 3.8580 mills was unanimously approved on a motion by Mr. Taylor McGrew and a second by Mrs. Marion McCray.
- (2) Discretionary Operating of .7480 mills was unanimously approved after a motion by Mr. Jeff Walker and a second by Mr. Darren Driver.
- (3) Capital Outlay of 1.500 mills was unanimously approved following a motion by Mr. Darren Driver and a second by Mr. Jeff Walker.

SCHOOL BOARD APPROVES RESOLUTION

Mrs. Marion McCray moved to approve Resolution Number 20-03 (ESE524) regarding the adoption of the final millage rates for 2019-2020. Mr. Taylor McGrew seconded the motion, which was unanimously approved. (Resolution on file in district office)
